Protocol Status

- The Neonatal EV Sepsis protocol has been activated at 25 sites, with 1 subject enrolled to date. We ask all activated sites to ramp up their screening activities. Begin working with your virology labs and neonatology teams to identify possible subjects for enrollment.
- 2) Our Valacyclovir PK protocol has been finalized and the NIH is preparing the FDA IND submission. The Central Unit is reviewing questionnaires to finalize site selection and is preparing the central IRB documents. We anticipate sending this protocol to sites in late 2021.
- 3) Longitudinal CMV protocol development is a bit delayed, with anticipated study initiation in early 2022.
- 4) Letermovir PK study design has been discussed and study initiation is still on track for early 2022.
